All that certain lot of land designated as Lot Number 20 in Block J having a frontage on Third Ave. of 50 feet and a depth of 150 feet, in Park Place, an addition to the city of Greenville, South Carolina, situated just outside the city limits of Greenville, as shown in a revised plat of said addition on file in the office of the Register of Mesne Conveyance for Greenville County, South Carolina, Plat Book A. Page 119 and being part of the same tract of land conveyed to J. W. Cagle, T. Q. Donaldson and William Wilkins by Alexander Stewart and Jacob H.
