(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release unto the said John Henry Honour, all that lot of land on Pendleton Road, just beyond the incorporate limits of the City of Greenville and near the Brandon Mills, known as No. 3, Honour Row, measuring on Pendleton Road South side sixty (60) feet more or less, Beginning at lot No. 2, Honour Row, Pendleton Road, running West sixty (60) feet to lot No. 4; thence South two hundred (200) feet to Southern R.R. right-of-way (be the same more or less); thence East to lot No. 2; thence two hundred (200) feet more or less back North to Pendleton Road. This property cannot be sold to a negro. on this property it is especially provided that no mortgage can be placed so long as it is owned by John Henry Honour, nor can it be sold unless the purchase money be reinvested in other real-estate, the privilege is accorded to said John Henry Honour to sell when ever he deems it to his advantage to do so only however to be reinvested in other real-estate for a Home, at the death of said John Henry Honour, the property to be sold and proceeds divided among his children, share and ahare alike.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said John Henry Honour, his heirs and assigns, forever.

AND I do hereby bind myself, --- heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said John Henry Honour, ---

heirs and assigns, against me and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
