Robin Pitman of Greenville County (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release unto the said Robin Pitman, All that certain piece, parcel or tract of land situate, lying and being in

Greenville County in the State aforesaid and in Glassy Mountain Township and runs as follows? Beginning at a stake 3X at the mouth of a ditch; thence up said ditch to the branch; thence with the meanders of said branch in a Northerly direction to a Chestnut-oak 3X; thence nearly West a straight line to a spanish-oak 3X; thence nearly North-west to a post-oak 3X; thence nearly North to a spanish-oak 3X; thence nearly North to a Pine 3X; thence nearly South-east to a Maple 3X; thence Nearly N.E. to a Pine; 3X, thence nearly East to a chestnut-oak 3X; thence nearly East to a spanish-oak 3X; thence nearly N.E. to a black-gum 3X; thence nearly South to a Pine 3X; thence nearly S.W. to a stone 3X; thence about West to a stone 3X (at the branch); thence a straight line to the beginning stake corner and is part of the Solomon Pitman Tract and is on branch waters of Bartons Creek, of Middle Tyger River, containing Fifty-two and two-fifths acres, more or less and bounded by lands of Sam Pitman, Massena Pruitt, H.E.
