Agreement and this Addendum and that Buyers shall have thirty days 500K which to cure said default before the Sellers proceed against any security given for the remaining indebtedness or as relates to the collateral assignment of the lease. It is further agreed that the collateral assignment of the lease referred to in Paragraph 6 of the Agreement is subject to all rights and consents of the Landlord under said lease. With reference to the security agreement and financing statement signed by Buyers, it is agreed that they may sell any inventory free of any claims by sellers. If any other property covered thereunder needs to be released, Sellers will give such release upon reasonable payments of the value thereof.

- 6. Paragraph 7 of the Agreement is modified in that although
 Buyers are given the right to use the corporate name "Pen Products,
 Inc.", Buyers do not intend to use the corporate name or in anywise
 infer to any parties that the Buyers have purchased the corporation
 which Buyers have not done nor have they assumed any corporate debts.
- 7. Sellers shall have the sole responsibility of paying any brokerage commissions that may be due concerning this transaction.
