TO: ALL AND SINGULAR SHERIFFS AND CONSTABLES OF SAID STATE AND COUNTY:
YOU ARE HEREBY COMMANDED to attach and seize all of the right, title
and interest of Butler Corporation of Anderson, Inc., the same being a lease-
hold interest in and to all that lot of land situate on the northwest side of
S. C. Highway 291 in the City of Greenville, in Greenville County, S. C., and
