NOTICE AND CERTIFICATE OF MECHANICS LIEN

TO: The Piedmont Company and Jesmon Construction Co., Inc., a subsidiary of the Bernstein Group, Inc.

NOTICE IS HEREBY GIVEN, THAT

William Ray Hatfield, d/b/a Pickensfield Construction Company is due the sum of Twenty Seven Thousand Seventy Seven and 10/100 (\$27,077.10) Dollars from Jesmon Construction Company, Inc., a subsidiary of the Bernstein Group, Inc. and the Piedmont Co. a statement of a just and true account of said indebtedness, with all just credits given, being attached hereto and made a part hereof, together with interest from the 15th day of August, 1980.

That said debt is due the undersigned for labor performed or furnished, and/or for materials furnished, and actually used in the erection, alteration or repair of buildings or structures situated on, or in otherwise improving, the real estate hereinafter described, by virtue of an agreement with, or by contract of, Jesmon Construction Co., Inc., a subsidiary of the Bernstein Group, Inc. the owner thereof, or a person or persons authorized by, or rightfully acting for, said owner, or said debt is due the undersigned because such improvements have been authorized by said owner. 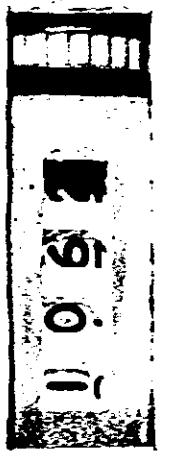
