payment of the debt so due and the costs of enforcing said lien upon the buildings or structures herein above

of land, with all improvements thereon, or hereafter constructed thereon,  
situate, lying and being in the State of South Carolina, County of Greenville,  
City of Greenville, as shown on a survey for Yvonne A. McPherson, dated April  
25, 1975, by Carolina Surveying Co., R. B. Bruce, Land Surveyor, Reg. #1952,  
being 2.43 acres, and being described by metes and bounds, as follows:
