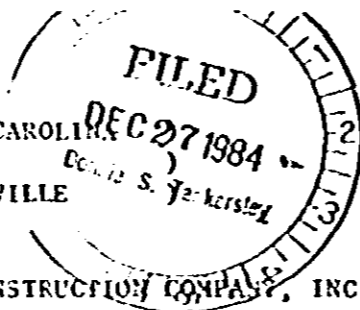

NOTICE AND CERTIFICATE OF
MECHANICS LIEN

TO: DIAMOND CONSTRUCTION COMPANY, INC., and SONOCO PRODUCTS COMPANY

NOTICE IS HEREBY GIVEN, THAT GOLDEN STRIP ASPHALT PAVING, INC. is due the sum of THREE THOUSAND ONE HUNDRED TWENTY FIVE and 00/100 (\$3,125.00) dollars from Diamond Construction Company, Inc. a statement of a just and true account of said indebtedness with all just credits given, being attached hereto and made a part hereof.

That said debt is due the undersigned for labor and materials furnished for the improvement of the below mentioned real estate, said labor, materials and improvements having been authorized by the owner of the real estate, or a person or persons authorized by or rightfully acting for said owner. That such labor and materials were last furnished on or about October 3, 1984.

That by virtue thereof, by the service and filing of this notice and certificate, and pursuant to the provisions of the statutes involved, to wit, Section 29-5-20 et seq., the undersigned has and claims a lien to secure the payment of the debt so due and the costs of enforcing said lien upon the real property hereinbelow described: (*and/or Section 29-5-10)

ALL that certain piece, parcel or tract of land, situate, lying and being in the Town of Fountain Inn, County of Greenville, State of South Carolina, located on the northern side of Georgia Street Extension on the eastern side of Babb Town Road, on the southern side of Seaboard Coast Line Railroad, and on the western side of Valley View Road, and containing 12.22 acres and shown as Tract A on plat entitled "Property Survey for O. B. Givens, Jr. and L. B. Givens" by Lindsey & Associates dated January 19, 1979 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at a railroad spike at the point of intersection of the center line of Valley View Road with the center line of Georgia Street Extension and running thence with the center line of Valley View Road, N. 12-35 E. 598.55 feet to an iron pin; thence leaving the center line of Valley View Road and running N. 42-30 W. 167.07 feet to a point in the center of the Seaboard Coast Line Railroad right-of-way; thence with the center of said railroad right-of-way, S. 70-00 W. 152.10 feet to a point; thence continuing S. 70-06 W. 100 feet to a point; thence continuing S. 71-26 W. 113.65 feet to a point; thence continuing S. 74-09 W. 100 feet to a point; thence continuing S. 77-27 W. 100 feet to a point; thence continuing S. 80-41 W. 100 feet to a point; thence continuing S. 83-51 W. 100 feet to a point; thence continuing S. 86-47 W. 100 feet to a point; thence continuing S. 89-37 W. 100.08 feet to a point; thence continuing N. 38-31 W. 33.21 feet to a point in the center of Babb Town Road; thence with the center of Babb Town Road S. 24-15 E. 306.66 feet to a railroad spike; thence leaving the center line of Babb Town Road and running S. 67-46 E. 331.04 feet to an iron pin; thence S. 9-45 E. 261.79 feet to an iron pin; thence N. 72-41 E. 300.31 feet to an iron pin in Georgia Street Extension; thence continuing in the same direction, 118.42 feet to a railroad spike in the center of Georgia Street Extension; thence with the center line of Georgia Street Extension, N. 65-32 E. 83.02 feet to the point of beginning.
