NOTICE OF MECHANIC'S LIEN

Personally appeared before me Joe Meyer who, being duly sworn, deposes and says that he is the accountant for Dillingham Construction Company, Inc. and as such is authorized to make this statement on behalf of Dillingham Construction Company, Inc. for the purpose of recording a Mechanic's Lien against the property described herein.

That Liberty Life Insurance Company is the record owner of the real property described herein.

That based on information and belief, Vector Corporation entered a contract with Liberty Life Insurance Company for the construction of improvements on the property described herein.

That Vector Corporation subcontracted certain excavation and grading work to Dillingham Construction Company, Inc.; that the work to be performed by Dillingham Construction Company, Inc. was completed on January 21, 1984.

That there is now due and owing to Dillingham Construction Company, Inc. the sum of One Hundred Ten Thousand Two Hundred Eighty-seven and 17/100 (\$110,287.17) Dollars, plus service charges accruing after April 18, 1984, and a reasonable attorney's fee for the filing and enforcement of this Mechanic's Lien.

That the property against which this Mechanic's Lien is asserted is described as follows:
