BEGINNING at an iron pin in the joint line of property of Grantor and Grantee held iron pin lying N. 10°45' E. 352 feet from an iron pin at the joint front corner of Grantor and Grantee on Melton Road and running thence with the line of Grantee N. 10°45' E. 350 feet to an iron pin in line of property now or formerly of Goldsmith and Timmons; thence S. 69°32' E. 100 feet to an iron pin; thence with a new line S. 27°15' W. 346.24 feet to an iron pin, the point of BEGINNING.

BEING the same property conveyed to the Grantor Charter Properties, Inc., by deed of Green Property Partnership and John D. McElroy, said deed being dated March 8, 1983, and recorded March 20, 1983, in the RMC Office of Greenville County in Deed Book 1335 at Page 222.

This conveyance is made subject to all easements, reservations and restrictions of record and the liens and operation of that certain Mortgage from Charter Properties, Inc. to First Union National Bank dated October 31, 1984 and recorded in Book 1687, Page 639, Greenville County RMC Office and that certain Assignment of Lessor's Interest in Lease dated October 31, 1984 and recorded in Book 1243, Page 444, Greenville County RMC Office, which the Grantee does assume and agrees to pay.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anyway incident or appertaining.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said CHARTER PROPERTIES PROJECT PARTNERSHIP #3, its successors and assigns forever.

AND Grantor does hereby bind its successors and assigns to warrant and forever defend all and singular the said premises unto the said Charter Properties Project Partnership #3, its successors and assigns against grantor and grantor's successors, assigns and every other person whomsoever lawfully claiming, or to claim the same or any part thereof.
