NOTICE IS HEREBY GIVEN, THAT

James L. Payne Enterprises, Inc., d/b/a J. P. Enterprises is due the sum of Sixty-Eight Thousand Sixty-Three and 31/100 (\$68,063.31) Dollars from G-H Associates, a Tennessee partnership, and Nabholtz Construction Corporation, a statement of a just and true account of said indebtedness, with all just credits given, being attached hereto and made a part hereof, together with interest from the date of May, 1988.

That said debt is due the undersigned for labor performed or furnished, and/or for materials furnished, and actually used in the erection, alteration or repair of buildings or structures situated on, or in otherwise improving, the real estate hereinafter described, by virtue of an agreement with, or by consent of, G-H Associates, a Tennessee partnership, and Nabholtz Construction Corporation, the owner thereof, or a person or persons authorized by, or rightfully acting for, said owner; or said debt is due the undersigned because such improvements have been authorized by said owner.
