BEGINNING at an old nail and cap at the intersection of a paved county road and Pink Dill Mill Road and running thence S. 50-16 W. 388.86 feet to a nail and cap in the center of Pink Dill Mill Road to a nail and cap at the intersection of a creek; thence running with the creek as the line, the traverse line of which are: N. 63-19 W. 179.44 feet, N. 38-27 W. 142.87 feet, and thence S. 34-00 W. 237.63 feet to an old iron pin approximately 5 feet N. 71-30 E. of the center line of the creek; thence from said old iron pin leaving creek and running with property now or formerly of J. H. Stokes N. 71-30 E. 492.89 feet to an iron pin; thence S. 01-00 W. 200 feet to an iron pin; thence N. 71-30 E. 232 feet to a nail and cap in the center of a paved county road; thence with the center line of said paved county road S. 01-00 W. 170.82 feet to the point of beginning.
