Vaughn estate dated July 2, 1956 prepared by H. S. Brockman and recorded in Plat Book LL at Page 31, in the R.M.C. Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Preston Drive at the joint front corner of Lot 17 and Lot 18 and running thence with Lot 18, S. 82-37 E. 161.3 feet to an iron pin at the joint rear corner of Lot 17 and Lot 18; thence N. 8-27 W. 198.2 feet to an iron pin on the southern side of Buncombe Road; thence with said road N. 80-14 W. 89.4 feet to an iron pin at the intersection of Buncombe Road and Preston Drive; thence with Preston Drive S. 4-29 W. 200 feet to an iron pin; thence still with said drive, S. 23 W. 90 feet to the point of beginning.
