SEND GREETING:

WHEREAS, the said W. A. Waldrop and Lula Waldrop
in and by C. F. Dill certain promissory note in writing, of
even date with these presents, well and truly indebted to

in the full and just sum of One thousand Fifty Dollars (\$1050.00)
Dollars, to be paid as follows: \$175.00 at the end of each and every
six months until the whole amount
with interest thereon from date at the rate of eight
per cent. per annum to be
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent of the
amount due upon said note besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That we the said W. A. Waldrop and Lula Waldrop
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said C. F. Dill
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us, the said W. A. Waldrop and Lula Waldrop
in hand well and truly paid by the said C. F. Dill

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said C. F. Dill

All that lot and parcel of land situate in the State
and County aforesaid, and in Greenville Township, front-
ing on the northwest side of Redstone Street, and
known as lot no. 5 on plat of lands of Summit
View, and recorded in the office of the R. M. C. of
said County, in plat book "A" page 75, and being
the same lot of land conveyed to C. P. Mims by
H. P. Burbage, by deed bearing date the 30th day of
April, 1912, and recorded in the office of the R. M. C.
for said County in Deed Book 19, page 158, and
having a frontage of fifty feet, and a depth of
one hundred fifty feet, and having a seven-room
dwelling house thereon; also all those seven
lots of land situate in said State, County and
Township, and being known on said plat as lots 1, 2,
3, 4 & 6 in Block "C" of said plat and fronting on the
northwest side of Redstone Street, and as lots nos.
7 and 8 in Block "B" of said plat fronting on Klondike
street, said lots of land being the same conveyed to
C. F. Dill by E. Inman, by deed dated December 11, 1917
and recorded in the R. M. C. office for Greenville
County, and in Volume 52, page 205 and being the
same lots of land conveyed to us by C. F. Dill.
