SEND GREETING:

WHEREAS, I, the said Josie L. Floyd  
in and by my certain promissory note, in writing, of  
even date with these presents, and well and truly indebted to Home Fund Life

Insurance Company, a Corporation  
in the full and just sum of Twenty five Hundred Dollars (\$2500.00)  
Dollars, to be paid one year from date

with interest thereon from date 17 Jan 1918 at the rate of 7 per cent. per annum to be  
computed and paid Semi-annually Home Fund Life Ins Co

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount owed by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of Five per cent of amount

due besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

bargain, sell and release unto the said Home Fund Life Insurance Company,

All that lot of land situate in Ward two, in the City of Green-  
ville, County of Greenville, State of South Carolina, on  
Pettigru Street, known as lot no. 139, Block "H," as shown on  
plat of East Park, said plat recorded in the R. M. C. office  
for Greenville County S. C. in plat book "A" page 383. This lot  
has a frontage of sixty (60) feet on the southeast side of  
Pettigru Street, and is the same lot of land conveyed to  
me by L. J. Jennings by deed dated September 29th 1914,  
and recorded in said R. M. C. office in Deed Book Vol. 27 page  
384.
