in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and
released, and by these presents do grant, bargain, sell and release unto the said *Journes + DuBose attorneys*

all that piece, parcel, tract or lot of land situated in *Greenville*
Township, Greenville County, State of South Carolina,

Springs and being near the city of Greenville, County of Greenville, State of South Carolina and being a part of the first subdivision known as City View, and being a portion of lot No. 11A, Block "J," according to plat of said subdivision recorded in R.M.C. office for Greenville County in plat Book "C," at page 112 fronting 50 feet on New Cut Road, beginning at an iron pin on said Road, 50 feet from corner of said New Cut Road and Smith Street and running in a northerly direction 143 1/2 feet, more or less, to a wire fence and iron pin between the lot herein conveyed and the lot or strip heretofore conveyed to A.W. Harrison by deed recorded in Volume 36, page 276 R.M.C. office for Greenville County; thence with said fence in an easterly direction towards Brandon Road 50 feet to an iron pin on line of said fence; thence in a southerly direction on line parallel with the line just described 143 1/2 feet, more or less, to an iron pin on said New Cut Road; thence with said New Cut Road, 50 feet to the beginning corner, being all of lot No. 11A, as shown by said plat, except a strip of 12 feet heretofore conveyed to A.W. Harrison as above described.
