Near the city of Greenville, beginning at a stake on the south side of the Easley Bridge Road 80 feet eastward from the Southeast corner of said Easley Bridge Road and Florida Avenue, and running thence along the Easley Bridge Road N. 71° 32' 00" feet to stake, corner of Easley Bridge Road and Georgia Avenue; thence with Georgia Avenue S. 9.30° 600 feet to stake, corner of Georgia Avenue and Peachtree Street; thence with Peachtree Street S. 71° 27' 00" feet to stake, corner of Peachtree Street and Florida Avenue; thence with Florida Avenue N. 22-10 W. 400 feet to stake N. 71° 07' 00" feet to stake; thence in a straight line 200 feet to the beginning corner, being all of the lot known and designated as Lot 1 and Lot 2 of West Highlands as shown on plat thereof made by W.
