Green, Tom Jones and others, Beginning at a stone 370 m; and run thence N 21 1/2 E 9.30 to iron pin at settle ment road; thence N 67 W. 7.54 to stone; thence S 4 1/4 W. 7.15 to stone; thence N 65 W. 16.65 to stone, thence S. 39 1/4 W. 17.76 to stone; thence S 53 1/4 E. 11.25 to stone; thence S. 65 1/2 W. 2.61 to stone; thence S 24 1/2 E 9.09 to stone; thence N 60 1/8 E. 29.57 to the beginning corner, containing 6 1/2 acres, more or less, and being the same land conveyed to us by J. E. Campbell, by deed dated the 2nd day of January 1920, and not yet recorded.
