All that piece, parcel or lot of land in Austin Township and Greenville County, State of South Carolina, and more particularly described as follows: Beginning at a point in the center of the bridge over Gilders Creek, which said point is also the center of the road and runs thence down the center of Gilders Creek as a line 16.00; thence S. 5-1/2 E. still down said Creek 2.00; thence on down said creek S. 31 E. 4.00; thence on down said Creek S. 6 E. 5.00 to a stone; thence leaving said creek S. 18-1/2 W. 6.70 to a black gum gone, wild cherry witness; thence 78-1/2 W. 5.20 to a stone; thence S. 83 W. 3.95 to a stone in bank of branch; thence S. 70 W. 7.12 to wild cherry; thence 82-1/2 W. 6.30 to stone; thence N. 13-1/2 W. 14.90 to a stone; thence N. 84 W. 11.80 to a stone; thence N. 13 E. 17.50 to oak stump; thence S. 59 E. 13.75 to stone; thence N. 71 E. 7.05 to maple on or near branch; thence N. 26 W. 2.40 up said branch to maple and ash; thence N. 20 E. 12.52 to a stone; thence N. 1-1/2 E. 14.30 to a stone; thence S. 77 E. 12.52 to a stone; thence S. 13-1/2 W. 8.35 to a stone; thence S. 63 E. 1.89 to a pine; thence S. 13 W. 2.52 to a white oak; thence S. 1-1/2 E. 9.10 to a point or old run in road; thence S. 90 E. 160 to the beginning point, contains 126-1/4 acres, more or less. The above courses and distances are the same as shown by plat made by W.S.
