with interest thereon from Oct. 25th. 1919 at the rate of 8 per cent. per annum to be  
computed and paid when all instalments are paid in full,  
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of Ten percent,

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said J. J. Riddle,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said C. Symes,

All those two (2) certain pieces, parcels or lots of land, situate, lying and being in the state and county aforesaid, just outside of the city limits of Greenville, S. C. in Section known as south Cherokee Park and known and designated as lots nos. 28 and 29 of south Cherokee Park as shown on a plat made by Jas. P. Willis surveyor and which is recorded in Office of R. M. Co. for Greenville County in plat Book "A" at page 130. Said lots having a frontage of Neowee Ave. of 60 foot each and a depth of 172 feet to a 15 foot alley and being the same lots of land as conveyed to me, the said J. J. Riddle, by C. Symes, by his deed of this date, which has not yet been recorded. This mortgage is given to secure the payment of the balance of the purchase price on the above described lots of land.
