all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the south side of Stone Ave. in the City of Greenville and having the following metes and bounds: Beginning at an iron pin on the south side of Stone Ave. two hundred and forty-five feet from the southeast corner of Stone Ave. and Rutherford Str. and running thence with Stone Ave. S. 83-13 E. Sixty feet to an iron pin at the corner of Carson's lot; thence with line of Carson's lot S. 0-0.5 W. One hundred and seventy-five feet to an iron pin; thence N. 83-13 W. Sixty feet to an iron pin; thence N. 0-0.5 E. One hundred and seventy feet to the beginning corner.
