Beginning at an iron pipe on the south side of Mills Avenue, 132 feet west of Ladson Street at joint corners of lots three and five, and running thence with the line of said lots S. 44-33E. 180 feet to an alley 16 feet wide; thence with the line of said alley S. 45-27 W. 66 feet to joint corners of lots five and seven; thence along the line of said lots N. 44-33 W. 180 feet to Mills Avenue. Thence along south side of Mills Avenue N. 45-27E. 66 feet to the beginning corner. Said lot being known and designated as No. 5 block E. on plat of property of O. P. Mills.
