in and by a certified in Full Henry P. McGee
even date with these presents of Greenville, S.C. note in writing, of
well and truly indebted to Henry P. McGee

for the full and just sum of Five Dollars
Dollars to be paid on or before October 25th 1920
with interest thereon from January 1st 1919 at the rate of 8 per cent. per annum to be
computed and paid quarterly

until paid in full; an interest not paid when due for three interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent
besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said Henry P. McGee

all that certain lot of land, situate in the City of Greenville, in the County and State aforesaid, known as lot no. 18, of Block D of Eagle Park, as shown on Plat recorded in R.M.C. office for Greenville County in plat book C page 238 on Prentiss Avenue, corner of lot #19 and running thence with Prentiss Avenue S. 66.49 E. 60 ft. to an iron pipe corner of lot #17, thence with line of lot #14 S. 33.30 W. 150.1 ft. to an iron pipe on an alley, thence with said alley N. 73.02 W. 36 feet, thence still with said alley N. 74 W. 22 ft. to iron pipe corner lot #19, thence with line of no. 19 N. 32.12 E. 154.1 ft. to the beginning corner, conveyed to me by W.C.
