computed and paid uninterruptedly

until paid in full, all interest not paid when due to bear interest at the same rate as principal and if any portion of principal or
interest be at any time past due and unpaid the whole amount of said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose on this mortgage, said note, and further providing for an attorney's fee of ten percent (10%) of the
amount due besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
