WHEREAS, we, the said O.K. Mauldin, Thos. S. Mauldin and J. L. Lane
in and by our (3) certain promissory note in writing, of
even date with these presents, are

well and truly indebted to

in the full and just sum of Two Thousand Three Hundred and Sixty-Two and 59/100 (\$2362.50)
Dollars, to be paid as follows: in one note \$315.00 due one year from date; one note
1023.75 due 2-1/2 years from date, one note 1023.75 due 5 years from
date with the right to anticipate any part or all of said payment
with interest thereon from date at the rate of six per cent. per annum to be
computed and paid Annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of Per (10%) per cent.

bargain, sell and release unto the said Jas. M. Richardson and H. B. Bates their heirs and assigns

forever:

All that certain piece, parcel and lot of land situate lying and
being in the County and State aforesaid and in the City of Grenville on
the north side of Murphy Street and being known and designated
as lot no. 7 upon a plat of the property of Jas. M. Richardson and
H. B. Bates, said lot being described as follows:

Beginning at an iron pin on north side of Murphy Street
at corner of lot no. 6 and running thence along line of lot no. 6 N
28.21 E. 79 feet and 6 inches to an iron pin at a 16 $\frac{1}{2}$ foot alley; thence
along said alley N. 69.30 W. 20 feet and 6 inches to an iron pin in
line of lot no. 8; thence along line of lot no. 8 S. 28.46 W. 79 feet and
6 inches to an iron pin on Murphy Street S. 60.30 E. 21 feet to the
