first day of each & every month and if unpaid when due to bear interest at same rate as principal until paid, and I..... have further

promised and agreed to pay ten per cent. of the whole amount due for attorney's fees, if said note.....be collected by an attorney or through legal proceedings of any kind, reference being hereunto had will more fully appear.

NOW, KNOW ALL MEN, That I.....the said *Elizabeth W. Mays*

.....in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note..... and also in consideration of the further sum of Three Dollars to me..... in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said.....

(1) Those two certain lots of land on the north side of Atwood Street, in the city of Greenville, in Ward 1, described as follows: Beginning at corner of present Elizabeth W. Mays lot and running thence with Atwood Street N. 48-0 E. 10 ft. to an iron pin thence N. 40-15 W. 310.7 ft. to an iron pin on Parker Street; thence S. 48-49 W. with Parker Street 90 ft. to an iron pin; thence S. 40-15 E. 114.6 ft., thence with the rear line of Elizabeth W. Mays' lot N. 49-50 E. 80 ft. thence S. 40-15 E. 194.6 ft. to Atwood Street, to point of beginning, being the same lot conveyed to me by Sam R. Zimmerman and Ferris M.
