All that certain lot of land situate, lying
and being in the county of Greenville, State of
South Carolina, known and designated as lot
no. eleven (11) of a subdivision of land known as
South Cherokee Park, represented by a plat made
by Jas. C. Miller, Surveyor, July 1, 1906, and recorded
in the R. M. C. office in and for Greenville County,
State aforesaid, in plat book R. page 130, the said
lot having the following lines and bounds to wit:
Beginning at a corner in the corner of Saluda Street
and Revere Avenue and running thence with
Saluda Street N. 63° 70' 172 feet to an alley;
thence with said alley S. 27° 70' 60 feet to a pin
in alley; thence S. 63° E. 172 feet to Revere Avenue;
thence with Revere Avenue N. 27° E. 60 feet to the
beginning corner, and being the same lot which
was conveyed to D. C. Gay by Cherokee Land Company
by deed bearing date May 9, 1911 and recorded in
R. M. C. office for the county aforesaid in vol. 16,

dated February 1920 and not yet recorded.
