at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Jas. M. Richardson, his heirs and assigns

power: All my one-half (1/2) undivided interest in and to all that certain piece, parcel and lot of land in the County and State aforesaid, in Ward 2, City of Greenville: Beginning at a point on the eastern side of Savinia Avenue 68 1/2 feet northerly from the northeast corner of Savinia Avenue and Franklin Avenue, and running thence along the line of the lot belonging to Harry Seuffel to a point on Savinia Avenue 38.2 feet from the point where Franklin Avenue changes direction, thence along Franklin Avenue 53 feet to a point on Savinia Avenue, 33 1/2 feet from the beginning corner, thence along Savinia Avenue 52 1/2 feet to the beginning corner. This being the exact lot of land this day described to me by the said Jas. M. Richardson.
