at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release, unto the said Mabel McB. Charles, her heirs

and assigns, all that lot of land situate in the City and County of Greenville, South Carolina: Beginning at a point in the west line of North Main Street (directly in center line of Main Street culvert) and running thence with said west line of Main Street S. 19 W. 101 feet to a stake near a large white oak tree (the north side of said tree being the line); thence N. 71 W. 175 feet to a stake; thence parallel with Main Street N. 19 E. 96 feet to a point in a line with the center of Main Street culvert and Townes Street culvert; thence to the point of beginning. This last named line is supposed to be the center line of branch when straightened.

Also all that other lot of land adjoining the above on the south and beginning on the southeast corner of the above lot on said Main Street and runs thence with said Street S. 19 W. 36 feet to a stake on edge of 12 foot alley; thence with said alley N. 71 W. 175 feet to a stake; thence N. 19 E. 36 feet to the above described lot; thence with line of that lot S. 71 E. 175 feet to the beginning corner.
