AND the said *I* agree to insure the house and buildings on said lot in the sum of not less than *Four Thousand* Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said *R. AND IT IS AGREED, By and between the said parties, that *I am* to hold and enjoy the said premises until default of payment shall be made.
