at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and

Released, and by these Presents do Grant, Bargain, Sell and Release, unto the said *Piedmont Live Stock Company* its

successors and assigns, All that tract, piece or parcel of land situated and being in the County of Greenville State of South Carolina and on waters of South Facolet River, adjoining lands of J. J. Gosnell, Frances Lindsay and others and being a part of the Levi Ward land, beginning at a poplar on said Ward's line - at a branch and running S. 68 E. 5 chains to a pine; thence S. 43 E. 20 chains to a pine; thence S. 10 E. 10 1/2 chains to a red oak on Ward's line; thence with said Ward's line S. 60 W. 26 chains to a chestnut oak; thence N. 45 W. 9 chains to a forked road oak thence N. 80 W. 32 chains to poplar on a branch; the beginning corner and containing sixty acres, more or less and being the land conveyed to me by Margaret Hulcomb, May Moore, Cna Seay, Minnie Bates, Mattie Evans and George Gosnell and recorded in Book 36 page 164 of office for R. M. C. for Greenville County, State of South Carolina.
