And *I* do hereby bind *myself, my* heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said *Minnie L. Agt. their successors* heirs and assigns, from and against *myself, my* heirs, executors, administrators and assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

AND the said *Mortgagor* agrees to insure the house and buildings on said lot in the sum of not less than *Fifteen hundred* Dollars, and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said *Mortgagor* and that in the event the mortgagor shall at any time fail to do so, then the said *Mortgagor* may cause the same to be insured in *their* name, and reimburse *themselves* for the premium and expense of such insurance under this mortgage.
