Haddick, his* heirs and assigns, from and against *ours* heirs, executors, administrators and assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

AND the said *Mortgagor* agree... to insure the house and buildings on said lot in the sum of not less than *5* Dollars, and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said *John M. Haddick* and that in the event the mortgagor shall at any time fail to do so, then the said *John M. Haddick* may cause the same to be insured in *John M. Haddick* name, and reimburse *John M. Haddick* for the premium and expense of such insurance under this mortgage.
