

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, All and singular the said premises unto the said S.O. Skelton, his heirs, and assigns, forever. And I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said S.O. Skelton, his heirs and assigns, from and against myself - heirs, executors, administrators and assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

AND the said Martha J. Carter agrees to insure the house and buildings on said lot in the sum of not less than Six hundred (\$600.00) Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said S.O. Skelton and that in the event the mortgagor shall at any time fail to do so, then the said S.O. Skelton may cause the same to be insured in his name, and reimburse himself for the premium and expense of such insurance under this mortgage.

And the said agrees to pay the said debt or sum of money with interest thereon, according to the true intent and meaning of the said Note, together with all cost and expenses which the said shall incur or be put to, including a reasonable attorney's fee, chargeable to the above described mortgaged premises, for collecting the same by demand of attorney or by legal proceedings.

Carter do and shall well and truly pay, or cause to be paid, unto the said S.O. Skelton the said debt or sum of money aforesaid, with interest thereon if any shall be due, according to the true intent and meaning of the said note and mortgage then this deed of bargain and sale shall cease, determine and be utterly null and void; otherwise to remain in full force and virtue.

AND IT IS AGREED, By and between the said parties, that I, Martha J. Carter on to hold and enjoy the said premises until default of payment shall be made.
