AND the said agree... to insure the house and buildings on said lot in the sum of not less than Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said Mortgagee and that in the event the mortgagor shall at any time fail to do so, then the said Mortgagee may cause the same to be insured in name, and reimburse for the premium and expense of such insurance under this mortgage.
