two tracts of land, situate, lying and being in Bladen County, Township and in of Greenville County, and State of South Carolina, about 3 miles west out of the town of Madison and being known and designated as Gate No. 3 and 4, according to a survey and plat of the land made by J. P. Marrow, Surveyor for the State of South Carolina, in the year 1905 and having bounds and courses and distances as shown on said plat. lot no. 3 beginning at a stake at the northeast corner of lot no. 2 and running thence along the line of lot no. 2 S. 28 W. 25 to a stake thence S. 70 E. 16.25 to a stone at the southwest corner of lot no. 4 thence along the line last mentioned, lat N. 20 E. 26.00 to a stake, thence N. 82 W. 80 to the beginning corner and containing 5.95 acres more or less, and being a part of the lands owned by the late Mrs J.
