TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Marguerite M. Stephens,

WHEREAS, I, the mortgagor,

hereinabove named *Mrs. Marguerite M. Stephens*,in and by me certain *Promise to pay* note in writing, of even date with these presents, well and truly indebted tothe mortgagee hereinafter named *Mariam B. Leach*.*Six hundred and eighty-eight \$688/100* DOLLARS, to be paid *on the day after date* in the full and just sum ofwith interest thereon from *December 30, 1921* at the rate of *Eight* per cent. per annum, to be computed and paid *quarterly* until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten* per cent.

besides all costs and expenses of collection, to be added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind or if any part of the money due on said note be not paid when due (all of which is recited under this mortgage), as is and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That

I, the said mortgagor, *Marguerite M. Stephens*,in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the mortgagee hereinabove named *Mariam B. Leach*, according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said mortgagor *Marguerite M. Stephens* in hand well and truly paid by the said mortgagee *Mariam B. Leach*,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

Mariam B. Leach, All that tract or lot of land in the Southwest part of the City of Greenville, Greenville County, State of South Carolina, on the North side of Vardry Street and on the East side of Anderson street, being lot of land conveyed to me by John W. Smith his deed dated July 8th 1899, recorded in Val. 11 page 725 excepting however that portion of said lot conveyed by me to George W. Brunsom, Jr. by deed dated October 21st 1909, recorded in Val. 5 page 515. Reference being made to both of said deeds for a full description of the lot herein mortgaged; it being my intention to include in this mortgage all of the lot conveyed to me by the said Smith, less that portion conveyed by me to Brunsom.

This mortgage is subject to a mortgage for \$3,000.00 executed by me to the American Bank first of June 1920, recorded in Val. 94 page 74; also to a mortgage for \$2203.54 executed by me to Mariam B. Leach December 31st, 1921, recorded in Val. 98 page 21.
