I, Mrs. A. M. Ayson, SEND GREETING:

WHEREAS, I, the said Mrs. A. M. Ayson, in and by my certain note in writing, of even date with these presents, well and truly indebted to

in the full and just sum of \$200.00 Dollars, to be paid

at the rate of 8 per cent. per annum, to be computed and paid

with interest thereon from maturity at the rate of 8 per cent. per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land situate lying and being in the State and County aforesaid, on the South side of Hubert Street in the town of Greer, and having the following meters and bounds, to-wit:

Beginning at an iron pin on Hubert Street, L. H. Littlefield's corner, and running thence with the said L. H. Littlefield's line one (100) feet to an iron pin; thence with L. H. Littlefield's line seventy (70) feet to a stone or iron pin on J. P. Parris' line; thence with the said J. P. Parris' line one hundred (100) feet to an iron pin on the South side of Hubert Street, J. P. Parris' corner, and running thence with the said Hubert Street to the beginning corner, this being the same lot of land conveyed to me by W. L. Ayson by deed dated the 20th day of December 1920.
