All that certain piece, parcel or lot of land, situate, lying and being in the County and State aforesaid, in the City of Greenville, on the north side of Stone Avenue, known and designated as lot D. of map # of the Stone Land, and having the following metes and bounds, as appeared from a plat recorded in the R. M. C. office for Greenville County in Deed Book 77, page 605. Beginning at a stake on Stone Ave. 327 1/2 feet westward from the north west corner of Townes Street and Stone Ave. and running thence N. 5 1/2 E. with line of lot C. 200 feet to a stake; thence with the line of lot 6 N. 84 1/2 W. 65 feet to stake; thence with line of lot No. 7 S. 5 1/2 W. 200 feet to Stone Ave. thence with the north side of Stone Ave. S. 84 1/2 E 65 1/2 feet to the beginning corner.
