NOW, KNOW ALL MEN, That the said John R. Moran

in consideration of the said sum of money aforesaid, and for the better securing the payment thereof to the said PIEDMONT SAVINGS AND TRUST COMPANY, according to the conditions of the said note of obligation, and also in consideration of the further sum of FIVE DOLLARS, to

me the said John R. Moran

in hand well and truly paid by the said PIEDMONT SAVINGS AND TRUST COMPANY, at and before the sealing and delivery of these Presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and, by these presents, do grant, bargain, sell and release unto the said PIEDMONT SAVINGS AND TRUST COMPANY, all that tract or parcel of land, situated in County of Greenville

State of South Carolina, and described as follows:

All that certain piece parcel or lot of land situate lying and being in Paris Mountain Township, County and State aforesaid on Lake Circle Road:

Beginning at a stake on Lake Circle Road and running thence with said road N 4-30 E. one hundred and fifteen (115) feet to an iron pin on Lake Circle Road, P. H. Boyd's corner; thence with said Boyd's line S. 85. 30 W. three hundred and sixty (360) feet to an iron pin on Allamant Road; thence in a southerly direction with said Allamant Road one hundred and sixty (160) feet to an iron pin on said Road; thence N. 86 E. two hundred and thirty three (233) feet to stake the beginning corner on Lake Circle Road, containing 34050 sq. ft. more or less, according to survey and plat made May 22nd A.D. 1925 by Dalton & Neves, Engrs.
