Green to me and having the following metes and bounds: Beginning at stone Johnsons corner thence N. 6.50 to iron pin; thence N. 44 1/2 E. 17.75 to iron pin; thence N. 10 E. 16.75 to iron pin on Clear Creek; thence down the meanderings of said creek to the mouth of a branch. thence up the meanderings of branch about 3.80 to stake. thence S. 22 3/4 W. 13.14 to White Oak; thence S. 65 3/4 E. 8.34 to stone; thence S. 4 1/2 E. 14.20 to stake on old line; thence S. 87 3/4 W. 23.08 to the beginning. containing 41 3/8 acres more or less.
