Whereas *W. E. William T. Eggleston and Elizabeth Eggleston*

of the County of *Greenville* in the State aforesaid (hereinafter referred to as the "mortgagor") in and by his certain promissory note or notes (hereinafter referred to as "notes," whether one or more) in writing, of even date herewith, is well and truly indebted to HOME BUILDING AND LOAN ASSOCIATION (hereinafter referred to as the "mortgagee"), which said mortgagor hereby admits to be a corporation duly chartered under the laws of said State and having its principal place of business at Greenville, in said County and State, in the full and just sum of *Twenty-seven Hundred & no/100*

dollars (*\$2700.00*), to be paid on or before the date when the *12th* series of the capital stock of said mortgagee shall reach maturity, with interest thereon from this date at the rate of *eight* per cent. per annum, payable *monthly*

on or before the first Tuesday of each and every month until paid in full; past due interest to bear interest at same rate as principal; both principal and interest to be paid in United States gold coin of the present standards of weight and fineness; all the terms and covenants of said notes being hereby made parts hereof as fully as if set out at length herein.

Now, know all men, that said mortgagor, in consideration of said debt and for the purpose of securing the payment thereof, and in further consideration of the sum of one dollar paid to said mortgagee at and before the sealing and delivery hereof (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released and by these presents does grant, bargain, sell and release unto the said mortgagee, and his heirs, successors and assigns all that certain lot, piece, parcel or tract of land situate, lying and being in the State of South Carolina and County of *Greenville* in *Greenville* Township.

Ward Four in the City of Greenville, and having the following metes and bounds, to-wit:- Beginning at a point on East Washington Road, corner of lot sold by W. E. Rasor to Edward McCady, deed dated December 5, 1922, and running thence with line of said McCady lot 190 feet to a point on right of way of C. & W. C. Ry. Co.; thence with line of said right of way S. 49-43 W. 45 feet to a stake; thence N. 27-13 W. 219.5 feet more or less, to point on Washington Road; thence with said Washington Road N. 69-15 E. 49-1/2 feet to the beginning corner, and being the Western half of the lot of land conveyed to W. E. Rasor by J. D. Bridges his deed dated September 19, 1921, and recorded in office of Register of Mesne Conveyances for Greenville County in Deed Book Vol. 76 at page 13, and by W. E. Rasor to William T. Eggleston and Elizabeth Eggleston by his deed dated July 30, 1923, and recorded in Office of Register of Mesne Conveyances for Greenville County in Deed Book H, at page 449.

Also, all that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, in Ward One of the City of Greenville, on the east side of Robinson Street, between Earle and Croft Streets and having the following dimensions, to-wit:- Beginning at a pin on the east side of Robinson Street fifty feet from the Southeast corner of Robinson and Croft Streets and running thence with Robinson Street S. 1-41 W. fifty (50) feet to a stake on Robinson Street; thence S. 83.33 E. one hundred eight feet nine inches to a stake; thence N. 1-41 E. fifty feet (50) to a stake; thence N. 83.33 W. one hundred eight feet nine inches to the beginning and being a part of Lot No. 27 of Section "C" of a plat of Stone Land Company, said plat recorded in Plat "A", pages 337-345 and being the same lot of land conveyed by deed of C. B. Stone to A. W. Reynolds dated December 22, 1922, and recorded in office of Register of Mesne Conveyances for Greenville County in Book "H" at page 412, and being the same lot of land conveyed by A. W. Reynolds to William T. Eggleston and Elizabeth Eggleston by deed not yet recorded.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining. To have and to hold all and singular the said premises unto the said mortgagee and his successors, heirs and assigns forever. And said mortgagor does hereby bind himself and his heirs, executors, administrators and successors to warrant and forever defend all and singular the said premises unto the said mortgagee and his successors, heirs and assigns from and against said mortgagor and his heirs, executors, administrators, successors and assigns and against every person whomsoever lawfully claiming or to claim the same or any part thereof; also, on demand at any time, to give any further written assurances which may be desired to protect the interests of said mortgagee, including a new note or notes and mortgage correcting errors in the originals.

- And said mortgagor hereby covenants and agrees with said mortgagee as follows:
- (1) That when the loan secured hereby is closed, there shall and will be no unsatisfied lien or encumbrance of any kind, prior to the lien hereof, affecting said premises or any part thereof, this being solemnly declared and represented by said mortgagor as a condition hereof and for the purpose of obtaining a loan hereunder.
 - (2) That said mortgagor shall keep all buildings and improvements now or hereafter on said premises in the best of condition and shall not remove, demolish or alter any such building or cut any timber without written consent of said mortgagee and shall not commit or permit waste or injury impairing the value of the premises as security for said debt; and in case of impairment, of which said mortgagee shall judge, said mortgagor hereby agrees to make, immediately upon demand, such repairs as said mortgagee may consider necessary to protect his interests; and upon default, said mortgagee may enter upon said premises and make the same.
