in consideration of the said debt and sum of money aforesaid, and for the better
securing the payment thereof according to the terms of the said note..... and also in consideration of the further sum of Three Dollars to me.....
in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and
released, and by these presents do grant, bargain, sell and release unto the said..... C. D. Allenall that piece, parcel, tract or lot of land situated in..... Greenville
Township, Greenville County, State of South Carolina,

Situate, lying and being in the County and
State aforesaid, and known as Lot No. 49 on
Plat of Monaghan Annex recorded in Plat
Book C, Page 63, R. M. C. Office for Greenville
County and having the following metes and
bounds, according to said plat, L.S.-W.L.;
Beginning on an iron pin on the south side of the
Parker Road corner off lot # 48, and running thence
with line of No. 48, S. 37 $\frac{1}{2}$ E. 150 feet, to a 10 foot
alley, thence with the alley N. 51 $\frac{3}{4}$ E. 55 feet to
an iron pin corner of lot no. 50; thence with
line of lot No. 50, N. 37 $\frac{1}{2}$ E. 150 feet to the Parker
Road; thence with said Road S. 51 $\frac{3}{4}$ E. 55 feet to the
beginning corner, and being the same lot conveyed
to me by Solomon Osteen by deed dated Dec. 11th 1919, and
recorded in Vol. 55 Page 104, R. M. C. Records for Greenville
County. Also: all that certain piece of parcel
or lot of land situate, lying and being about two
miles west of the City of Greenville, in the County
and State aforesaid, in Section known as City
view:- Beginning at a stake on Hunt street,
two hundred and fifty-eight feet from Parker's
line and running thence in an Easterly direction
125 feet to a stake; thence in a southerly direction
50 feet to a stake in line of lot No. 117; thence in a
Westery direction with line of said lot 125 feet to
a stake on Hunt Street; thence on line of said
street in a Northerly direction 50 feet to the be-
