SEND GREETING:

WHEREAS, we, the said Otis Jamison and D. Jack Goodwin

in and by our certain promissory note in writing, of even date with these presents, are well and truly indebted to

W.D. Parrish and T.C. Gower

in the full and just sum of Eight hundred (\$800.00)

Dollars, to be paid on or before one year after date

with interest thereon from date at the rate of eight per cent. per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said W.D. Parrish and T.C. Gower

All that piece, parcel or lot of land situate, lying and being in Greenville Township, County and State aforesaid, just south of the corporate limits of the City of Greenville, on the north side of Cateechee Road, and being known and designated as Lot No. 78 on a plat of Cherokee Park, as shown by plat recorded in plat book C, page 96 of the R.M.C. Office for Greenville County, and having the following metes and bounds, to-wit: Beginning at a stake on the north side of Cateechee Road at the southwest corner of Lot No. 79, and running thence with the line of Lot No. 79, N. 14-15 W. 173 feet to a stake; thence S. 75-45 W. 60 feet to a stake, northeast corner of lot No. 77; thence with line of Lot No. 77, S. 14-15 E. 182 feet to a stake on the north side of Cateechee Road; thence with the line of Cateechee Road N. 68 E. feet to the beginning corner. Being the same lot of land this day conveyed to us by W.D. Parrish and T.C. Gower, this mortgage being given to secure a portion of the purchase price thereof.
