until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue  
thereon and foreclose this mortgage, said note further providing for an attorney's fee of

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said Bessie Norris Silman

those lots or parcels of land situate in the County  
and State aforesaid, near the corporate limits of the City  
of Greenville in the sub-division known as Park Place  
and situated between the Rutherford and Paris Mountain Roads,  
designated as lot # 13 and part of lot # 14 in Block E on  
plat of said sub-division recorded in Plat Book A,  
page 149, R. M. C. Records for Greenville County, having  
the following metes and bounds, to-wit: -  
lot # 13 has a frontage of 50 feet on Fourth Street and  
runs back in parallel lines 318.7 feet and 243 feet,  
respectively, and has a width in the rear of 85.5 feet.  
Also lot # 14, which has a frontage of 50 feet on  
Fourth Street and runs back in parallel lines 243 feet  
and 170 feet, respectively, less a part of said lot having  
a frontage of 25 feet conveyed by me to C. L. Cleveland  
by deed dated Dec. 4, 1912, and recorded in Vol. 39, page  
485.

These lots were both conveyed to me by J. O. Donaldson  
attorney in fact for Charles W. Hopkins by deeds dated  
October 23, 1908, and February 26, 1909, and recorded  
in Vol. 6, pages 311 and 312, respectively. Reference being
