WHEREAS, I, the said Edna Seyle Ware

in the full and just sum of Sixteen Hundred Ninety-five and 22/100  
Dollars, to be paid On or before Dec. 30, 1921

with interest thereon from date at the rate of 8 per cent per annum to be  
compounded annually paid 9 day of Sept

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue  
thereon and foreclose this mortgage, said note further providing for an attorney's fee of

Fifty (\$50) Dollars besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said J. R. Owens, his heirs and assigns forever.

state and County aforesaid, in Greenville Township and  
having the following metes and bounds, to-wit: Beginning  
at an iron pin on Pendleton Road, running thence  
with said road N. 80-04. 80.7 feet to iron pin, thence  
N. 10-30 E. along line of Farmers Loan & Trust Co. 124.5  
feet to an iron pin; thence N. 45-35 W. along line of Farmers  
Loan & Trust Co. 79.5 feet to an iron pin thence along  
line of J. J. Seyle S. 80-04 80.5 feet; thence along line of  
J. J. Seyle S. 11-09 E. 181.9 feet to beginning corner on
