all that piece, parcel, tract or lot of land situated in  
Township, Greenville County, State of South Carolina,

and being known and designated as lot No. 2  
as shown on plat made by R. C. Dalton June 1920, and  
having the following metes and bounds according  
to said plat, to wit: Beginning at an iron pin on  
Taylor Ave. 150 feet from Jenkins Street at joint corners  
of lots 1 and 2 running thence with lines of said  
lots No. 75.30 W. 89 feet to iron pin; thence S. 14.49 W.  
46 feet to iron pin corner of lot No. 3; thence with line  
of lot No. 3 S. 75.30 E. 89 feet to iron pin on Taylor Ave.
