WHEREAS, We, the said William W. and Julia Cole

in and by our certain promissory note in writing of even date with these presents are
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in
the full and just sum of Thirty-three hundred, fifty and 50/100 (\$3350.50)

DOLLARS,
to be paid on or before the date when the Series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent per annum, payable weekly on or before Saturday night of each and every week until paid in full, and if we fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE BUILDING AND LOAN ASSOCIATION

That certain lot of land situate, in the State of South Carolina, County of Greenville, about 2 1/2 miles North of the City of Greenville, in the subdivision known as Sans Souci Villa and being known and designated as Lot No. 51, Block E., according to a plat recorded in R.M.C. Office for Greenville County in Plat Book A., page 510, and having the following metes and bounds to-wit:
Beginning at a pin on the West side of Furman Road, joint corners with Lot No. 50, and running thence along joint lines of Lot No. 50, N. 57-25 W. 180 feet to a pin; thence N. 13-30 E. 61.6 feet to a pin; thence S. 57-25 E. along joint lines of Lot No. 52, 182 feet to a pin on Furman Road; thence along said Furman Road S. 13-30 W. 60.5 feet to the beginning corner.
