I, A. D. Ellenburg SEND GREETING:

WHEREAS, I, the said A. D. Ellenburg

in and by my certain promissory note in writing of even date with these presents am
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in
the full and just sum of Thirty-three hundred (\$3300.00)

DOLLARS,

All that piece, parcel or lot of land situate, lying and being in the Fourth Ward of the City of Greenville on the north side of Choice Street, County Road Street aforesaid, and being known and designated as Lot No. 27 of subdivision known as Oakland Heights, according to plat of record in Plat Book "C" at page 147, and having the following metes and bounds, to-wit:
