WHEREAS, I, the said Hazel M. Hughes

in and by my certain promissory note in writing of even date with these presents well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Fourteen hundred (\$1,400.00)

DOLLARS,

Beginning at an iron pin on the North side of Cateechee Road, joint corner of lot of Rita B.
